Thank you in advance for your generosity.

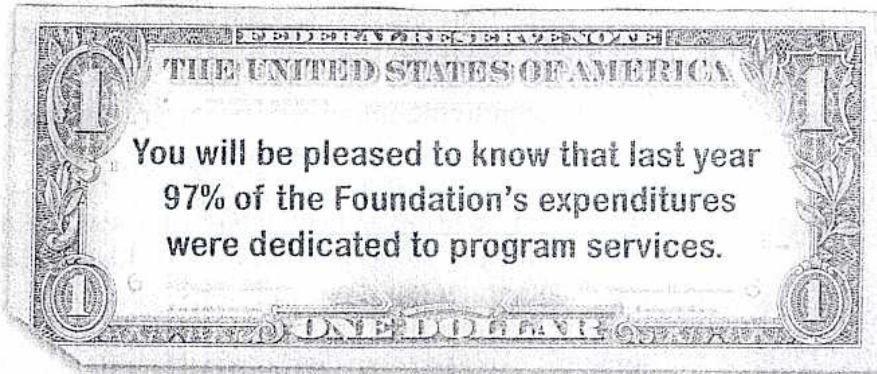
